The Paintball Activity is available to all campers participating in Lohikan's elective program (including super juniors - 5th graders). Space is limited and reservations are taken on a first-come, first-serve basis. The cost of participation is \$30 per session.

A session typically extends 3+ hours and includes 4+ games, 400 paintballs and a safety orientation class. Games are conducted on 2 paintball fields located on Lohikan's south mountain which covers a variety of terrain, natural and man-made bunkers and 10 acres of play area. The camp provides the paintball markers, safety masks, paintballs and CO2 filled gas canisters. Campers are permitted to bring their own paintball markers if they desire. Campers are NOT permitted to bring their gas canister or paintballs. Gas canisters brought to camp will be confiscated.

PAINTBALL RELEASE FORM

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of being permitted to participate in any way in the sport and activities of paintball under the auspices of Camp Lohikan and the American Paintball League, I acknowledge, appreciate and agree that:

1. The risk of injury from the activity and weaponry involved in paintball is significant, including the potential for permanent disability and death, and while particular protective equipment and personal discipline will minimize this risk, the risk of serious injury does exist.

2. I fully understand and acknowledge that: (a) risks and dangers exist in my child's participation in paintball activities and my child's use of paintball equipment; (b) my child's participation in such activities and/or use of such equipment may result in injury or damage to personal property including the potential for permanent disability and death; (c) these risks and dangers may be caused by the paintball activity operator, camp staff members or other participants, or by accidents, or by forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, selection of trail or uneven terrain on the playing field, weather conditions, injuries and/or welts or bruises caused by the paintballs, and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment.

3. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of those persons released from liability below, and assume full responsibility for my child's participation.

4. I understand that the activities of paintball are physically and mentally intense. I understand that the rules of play will be reviewed with my child during the safety orientation class. I have instructed my child in the importance of knowing and abiding by the rules, regulations and procedures established for the safety of the paintball participants and my child has agreed to do so. I have further instructed my child to bring to the attention of the nearest paintball instructor any unusual or unnecessary hazard observed during his/her participation in the activity.

5. I, myself and on behalf of my heirs, assigns, personal representatives and next of kin and on behalf of my child, hereby release, discharge, and agree to hold harmless from liability the American Paintball League (APL), Camp Lohikan, its owners, directors, officers,

employees and agents ("Releasees"), with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releasees or otherwise, except that which is the result of gross negligence and/or wanton misconduct.

6. I hereby certify that I, as parent/guardian with legal responsibility for this participant, do consent and agree not only to his/her release of the American Paintball League (APL), Camp Lohikan, and all other Releasees but also agree to release and indemnify the Releasees from any and all liabilities incident to his/her involvement in these programs for myself, my heirs, assigns, and next of kin.

7. I understand and agree that this agreement covers each and every paintball activity and event in which my child participates hereafter.

8. I hereby acknowledge that this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by Releasees, and is intended to be as broad and inclusive as permitted by the laws of Pennsylvania and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

9. My child is in good health. I understand that strenuous physical exertion may be required and my child has no known physical disabilities or health problems which will present any risk to his/her participation in the activities.

10. I have been advised that my child must wear approved protective eye goggles which will be provided by Camp Lohikan. No other padding, gloves or clothing is provided. Campers are required to wear long pants and a long sleeved shirt when participating in the activity. It is recommended (but not required) that boys wear athletic supporters with cups. I also understand and agree that Camp Lohikan will not be held responsible for damages to clothing or personal belongings. (Paintballs are water soluble, biodegradable, and non-toxic.)

11. I permit the use of any photos, slides, films, videos or sketches of him/her taken during the activity for commercial purposes.

12. I have read and agree to this Release of Liability Agreement and Assumption of Risk Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement.
