ENROLL ME FOR LOHIKAN'S **MINI-CAMP!** The 7 day (Aug. 16-22) tuition is \$800. Lohikan's Mini-Camp Program includes all of the following: 1 to 3 Staff to Camper Ratio, Tennis, Horseback Riding, Quads-ATV'S, Jet Skiing, Swimming, Waterfront Activities, Arts & Crafts, Basketball, Archery, Volleyball, Hiking, Ropes Course, Zip Line, Evening Activities... *and lots more fun!* The mini-camp deposit is \$400.

This application must be signed on the reverse side. A deposit of \$1000.00 is required.

CAMP TUITION

A deposit of \$1000.00 is required to process the camper's application (\$400 for mini-camp). The balance is due upon receipt of the camp invoice which should be received in about a week after registration.

The camp tuition includes: lodging, board, laundry service (every week), camp doctor and nursing care, all program activities (except horseback riding scheduled in excess of 1 period a week, jet skiing, paintball and quad/dirt bike riding), and camp newsletters.

CANTEEN FUND CHARGE

The charge for the camper's canteen fund is the only mandatory expense charged in addition to the camp tuition. The canteen fund covers: (1) the camper's snack bar allowance (2 items - 5 days a week), (2) a Camp Lohikan t-shirt, and (3) camp trips and admissions to amusement parks including travel arrangements. The canteen fund charge is \$250 for the full season, \$175 for 6 weeks, \$130 for the half season, \$40.00 for the July 8 - July 20 & July 21 - August 3 (13-14 day) sessions and \$80.00 for the June 24 - July 6 and August 5 - August 16 (12-13 day) sessions which include the July 2nd and August 8th Amusement Park Trips.

BUS & BAGGAGE TRANSPORTATION CHARGE

Bus and baggage transportation is available 5 times during the camp season: (1) June 24th, (2) July 20th, (3) July 21st, (4) August 16th, (5) August 3rd (only NY and NJ). Our bus transportation services the New York, New Jersey, Philadelphia and Baltimore areas on the dates 1-4. The bus and baggage service is an **optional expense**. The charge for this service is \$170.00 round trip or \$90.00 one way except the Baltimore stop. The Baltimore service is \$180.00 round trip or \$95.00 one way. There is a 1 duffel, 1 trunk limit. Special rates apply to airport pickups. Please call our office for rates.

LINEN RENTAL (OPTIONAL)

The camp tuition includes the weekly laundering of the camper's clothes and linens. If the parent desires, the camp can supply blankets, sheets and pillowcases. The linen charge is \$100.00 for the full season, \$75, \$50 and \$25 for the 6 week, half season and 13 day session respectively.

CAMPER TREATMENT AUTHORIZATION AND MEDICAL INSURANCE

Camper's are required to carry medical insurance. Certain illnesses or injuries are referred by the Camp's Infirmary Staff to outside medical professionals whose fees are not covered by the camp tuition or the canteen fee.

If it is necessary, in the judgment of the camp director, to use outside medical, surgical or dental aid for the camper's health, *the parent(s) or legal guardian hereby authorizes him to obtain this medical care and further agrees to pay for the medical services provided whether or not the medical expense is covered by the parent's or legal guardian's insurance policy.*

REFUND OF TUITION PAYMENTS

If a camper leaves camp before his or her scheduled departure date, it is understood and agreed that Camp Lohikan will refund **one-half** of the camp tuition for the days that the camper leaves early. If the camper's enrolled session is reduced after March 15th (i.e. a change from full to first half, assuming space exists at the time of the request) or the enrollment is cancelled, **one-half** of the difference in the tuition charge is not refunded (or considered forfeited). **There is no refund when a camper leaves camp with 14 days or less remaining in the camper's enrolled session.** There is no refund for the days missed if the camper arrives late in camp.

Camp Lohikan reserves the unrestricted right to dismiss, without a refund, any camper who exhibits emotional, psychological or behavioral conditions that are disruptive to the camp program or that are harmful to himself or the well-being of other campers or staff.

If an enrollment is cancelled before **March 15th**, all payments are refunded except for a \$150.00 administrative charge. Enrollments cancelled after March 15th will forfeit payments made up to one-half of the tuition charge. *Refunds are made after the camp season but before September 30, 2012.*

CONDITIONS OF ENROLLMENT

Camp Lohikan strives to provide positive camp experiences for children with various needs whenever possible. However, Camp Lohikan does not provide programs that are rehabilitative or therapeutic in nature, and does not specialize in serving children with special needs, including children with severe emotional, social, or behavioral difficulties. Please provide information (attach a separate sheet) regarding your child's special needs, including any disabilities, disorders or medical problems with this application form. It is important to determine if the Camp Lohikan experience is appropriate for your child prior to attending camp. Failure to provide adequate information prior to your child attending camp may result in the camper being sent home without a refund. Lohikan cannot accept children who do not have the promise of living cooperatively with others.

♦ I understand and certify that my child's participation in Camp Lohikan and its activities (on or off-camp) is completely voluntary and I have familiarized myself with the camp's program and activities in which my child will be participating. I recognize that certain hazards and dangers are inherent in the Camp's programs particularly, but not limited to horseback riding, lake and pool swimming, water skiing, water sports, rock climbing, backpacking, hiking on mountain trails, cabin overnights, river canoe trips, circus arts, flying trapeze, gymnastics, tetherball, high and low ropes course, zip line, cycling on mountain trails and public roads, land sports, athletic competitions including bodily contact and contact with equipment and balls, inter camp games, lacrosse, baseball, archery, riflery, mt. boarding, skateboarding and inline skating, use of power tools and equipment in certain creative arts activities, and travel in camp-owned and/or leased vehicles. I acknowledge that, although Lohikan has taken safety measures to minimize the risk of injury to camp participants, the Camp cannot ensure nor guarantee that the participants, equipment, premises, and/or activities will be free of hazards, accidents or injuries. I hereby assume these risks and agree to hold harmless and hereby release, discharge and agree to indemnify Camp Lohikan, its directors, owners, agents and employees from all liability for loss, damage, injury or illness to the camper or camper's property related to his/her participation in the camp program. I have also instructed my child in the importance of knowing and abiding by the camp's rules, regulations (i.e. activity attendance) and procedures for the safety of camp participants, the requirement that campers attend scheduled activities and remain supervised at all times, and my child has agreed to do so.

♦ I permit the use of any photos, video, slide, film, sketches or comments of my camper for commercial purposes.

♦ Camp Lohikan is not responsible for articles of clothing or personal belongings lost or damaged by fire, theft or laundry.

♦ A finance charge of 1.5% per month will be applied to all outstanding debts. Accounts which have not been paid within 60 days of billing will be subject to attorney fees (at least \$1500) and costs of the court and collection.

♦ It is agreed that the venue and place of trial of any dispute or cause of action arising between the parties, whether out of this agreement or otherwise, shall be the Court of Common Pleas located in Wayne County, Pennsylvania, and shall be construed in accordance with the laws of Pennsylvania. If the camp is successful in any litigation, it is agreed that the losing party will reimburse the camp for all attorney fees and costs of litigation.

♦ The parent hereby states that the camper is in good, normal health and has no abnormal physical or mental handicaps unless otherwise indicated on the aforementioned attached sheet. The parent hereby states that the camper is of sufficient maturity to properly care for his/her hygiene and participate in the camp's program.
