2. You must pass a safety test that will take place before the lesson begins. Campers must demonstrate that they can balance and ride a bicycle before getting on a dirt bike. Campers must demonstrate that they have the capacity to understand the various dirt bike controls, i.e., brake, accelerator, gears.
3. Parents must sign the Dirt Bike Release which is printed on the right.

## **DIRT BIKE ACTIVITY RELEASE FORM**

Assumption of Risk, Waiver and Release of Liability, Indemnity Agreement

In consideration of permitting my child to participate in the dirt bike riding activity conducted by Camp Lohikan I, for myself and on behalf of my child, my personal representatives, heirs and next of kin do the following:

1. I hereby acknowledge that dirt bike riding is a potentially dangerous activity and involves the risk of serious injury and/or property damage. While protective equipment, safety procedures and personal discipline will minimize this risk, the risk of serious injury does exist.
2. I fully understand and acknowledge that: (a) risks and dangers exist in my child's operation of a dirt bike; (b) my child's participation in such activities and/or use of a dirt bike may result in injury, or damage to personal property; (c) these risks and dangers may be caused by the dirt bike activity operator, camp staff members or other participants, or by accidents, or by forces of nature or other causes. Risks and dangers may arise from foreseeable and unforeseeable causes including but not limited to: the selection of the quad/dirt bike track, quad/dirt bike trail or uneven terrain, weather conditions, and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment.
3. I understand that the activity of dirt bike riding is physically and mentally intense. I have instructed my child in the importance of knowing and adhering by the rules, regulations and procedures established for the safety of dirt bike riding participants and my child has agreed to do so.
4. I hereby release, waive and discharge Camp Lohikan, its owners, directors, officers, employees and agents (the Releasees) from all liability to myself or my child, and my personal representatives, for personal injury or property damage related to the activity if caused fully or in part by the camper's violation of camp rules or safety regulations.
5. I hereby assume full responsibility for any risk of bodily injury or property damage related to my child's participation in the dirt bike activity, whether foreseen or unforeseen, if caused fully or in part by my child's violation of camp rules or safety regulations.
6. I hereby acknowledge that this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of the Releasees, and is intended to be as broad and inclusive as permitted by the laws of Pennsylvania and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
7. I have read this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, am aware of its legal consequences, and have signed it freely and voluntarily without any inducement.
8. I hereby certify that I am the parent or guardian with legal responsibility for this child.
