RAFTING TRIP RELEASE FORM

Waiver and Release of Liability, Assumption of Risk & Indemnity Agreement

In consideration of permitting my child to participate in the rafting trip activity conducted by Camp Lohikan I, for myself and on behalf of my child, my personal representatives, heirs and next of kin do the following:

1. I hereby acknowledge that trips off camp grounds, traveling in motorized vehicles and rafting on the Delaware River are potentially dangerous activities and involve the risk of serious injury and/or property damage. While particular protective equipment and personal discipline will minimize this risk, the risk of serious injury does exist.
2. I fully understand and acknowledge that: (a) risks and dangers exist in my child's participation in rafting activities; (b) my child's participation in such activities and/or use of such equipment may result in injury or illness or damage to personal property; (c) these risks and dangers may be caused by the raft livery provider (Landers Rafting), camp staff members or other participants, or by accidents, or by the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to: selection of trail or river route, water level, weather conditions, risks of falling out of a raft, and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment; and (d) I hereby accept and assume these risks and dangers.
3. I have been advised that my child must wear an approved personal flotation device at all times while on the water. I understand that the rafting activity is physically and mentally intense. I have instructed my child in the importance of knowing and adhering by the rules, regulations and procedures established for the safety of rafting participants and my child has agreed to do so.
4. I hereby release, waive and discharge Camp Lohikan, its owners, directors, officers, employees and the raft livery provider (the Releasees) from all liability to myself or my child, and my personal representatives, for personal injury or property damage related to the activity if caused fully or in part by my child's violation of camp rules or safety regulations.
5. I hereby assume full responsibility for any risk of bodily injury or property damage related to my child's participation in said activity, whether foreseen or unforeseen, if caused fully or in part by my child's violation of camp rules or safety regulations.
6. I hereby acknowledge that this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of the Releasees, and is intended to be as broad and inclusive as permitted by the laws of Pennsylvania and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
7. I have read this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, am aware of its legal consequences, and have signed it freely and voluntarily without any inducement.
8. I hereby certify that I am the parent or guardian with legal responsibility for this child.
